

Outreach Minutes
April 9, 2005

1. **Meeting called to order at 8:30 am.**

2. **Public Comment** - a proposal was submitted by Richard Pineda a new resident of Tujunga. He is working on fulfilling a requirement to receive a certificate in Emergency Management.
