# **MINUTES**

# Sunland-Tujunga Neighborhood Council Regular Meeting of 05/08/2002

Ken McAlpine called the meeting to order at 7:05 p.m. There were about 80 people in attendance. The Pledge of Allegiance was said.

#### Welcome Newcomers

Ken welcomed all the newcomers and gave a brief overview of what a Neighborhood Council is and does.

## Open Forum/Announcements

- -Laurel Fest mentioned that she has been checking with other community groups to find out if another night and/or time would allow more people to participate in the Neighborhood Council.
- -Mark Fogwell commented that the proposed ARCO station will affect the community and offered to answer questions on it. He also stated that Trader Joes has expressed interest in the lot.
- -An individual commented that the used car dealerships on Foothill Blvd. are making it look like Van Nuys Blvd.
- -Elaine Brown mentioned that the signages on the car dealerships do not fit the Specific Plan and complaints can be made.

## Recognition of Guests and Dignitaries

Ken introduced the guests and dignitaries present at the meeting.

## Dale Thrush, Planning Deputy for Council member Wendy Greuel

Dale Thrush spoke on various planning issues. Work is being done to bring Trader Joes and Starbucks to our community. Grading has begun on the Gas Company Project. The Mekhitarist Fathers' School will acquire the old ARCO lot. June 20<sup>th</sup> is the hearing date for ARCO. The public hearing on the Scenic Plan is on May 30<sup>th</sup>. Mr. Thrush has been told that the requests of 6723 Foothill Blvd., formerly the Canyon Theater, have been approved, but he hasn't received the documents yet.

#### Welcome Council member Wendy Greuel

Ms. Greuel made several announcements. It appears that escrow will soon commence on the 9 acres at Oro Vista that will be made into a park. \$30,000 was approved by the Housing Committee for Commerce Avenue. A Pet Fair will be held on June 8<sup>th</sup> at Sunland Park. It will start at 10am and go all day. Public Works day will be on May 21<sup>st</sup> in the Kmart parking lot. There is money that needs to be put into the community and Ms. Greuel will be reviewing various requests to get that money distributed by the deadline.

#### Programs - City hood and Sunland-Tujunga Temporary Aid Center

Oscar Mendoza, President of Residents for Independence, spoke on behalf of Valley Vote. Mr. Mendoza gave a presentation stating reasons to support Valley Secession. Five questions were taken and answered.

Mary Shotwell announced that the Sunland-Tujunga Temporary Aid Center at the Sunland-Tujunga Municipal Building provides free food to residents of Sunland and Tujunga in need.

Samantha Stevens spoke on behalf of One L.A. (opponents of secession). She presented reasons to oppose secession. Five questions were taken and answered.

## Treasurer's Report

Nedd Brown reported that we had no change in the income since last month's report.

# **Correspondence Report**

Brenda McAlpine reported that we now have 151 voting members. She also reported that she had received information on the Street Faire, which will be held in October. Brenda also acknowledged Shirley Kellstrom, Parliamentarian, who was elected President of Valley Sunset District BPW.

Reports were provided on Music in the Park, Planning, Outreach, Safety, Redistricting and Scenic Plan.

Elaine Brown moved that the Neighborhood Council write a letter to Wendy Greuel to put a moratorium on all plan approvals as to construction on the ridgelines as disputed in the San Gabriel/Verdugo Mountains Scenic Preservation Specific Plan until said plan is in place. The motion was seconded and passed.

#### **Unfinished Business**

Ken McAlpine announced that a committee will be formed to review additional Hallmark Project options. The committee will be appointed based on those who volunteer.

#### **New Business**

Debate Committee: Ava Wrightsman announced that volunteers are needed to form a committee to help on the Valley Vote v. One L.A. debate that is being sponsored by the STNC on Wednesday, May 22 at 7:00 p.m.

Independence Day Committee: Ken McAlpine announced that three volunteers are needed for the committee.

Street Faire: Brenda McAlpine announced a sign up sheet was available for those who would like to help on the Street Faire.

#### Advertising:

Brenda McAlpine moved that the NC spend enough money to get 3 months of flyers into the new community newspaper. The motion was seconded. Discussion ensued and Mike Hall moved to table it to the next meeting. Motion seconded and passed.

Committee Populating (filling vacancies on committees): John Waters announced that the NC needs to decide to appoint the vacant committees or leave them unpopulated.

Mike Hall moved that the Bylaws Committee not have any mandatory standing committees except Grievance, Audit, Nominating, and Bylaws and that the Council be permitted to add any committees needed to further our mission. The motion was seconded and passed.

Community Organization Liaison: John LaRocca announced that he is willing to represent the NC in discussion with businesses and the Chamber of Commerce for the Neighborhood Council.

DAC Structure Committee: Ken McAlpine announced that volunteers are needed to formulate a structure for the Design Advisory Committee.

Mr. Aunders moved that the Neighborhood Council draft a letter to the North Valley Planning Commission stating opposition to ARCO's proposed development of the Commerce and Foothill old Sunrise Ford dealership location for a 20 pump fueling station, 24-hour AM/PM, and 24-hour car wash. The motion was seconded and passed.
