Cindy mentioned that FTDNC was holding their meeting, also taking place that night with discussion about the historic overlay zone they are proposing.

Deborah Ray moved to appoint David Cain as STNC's liaison to the DWP oversight committee. Motion carried unanimously.

D. Deborah Ray moved, "That the Director of City Planning move up the Sunland-Tujunga, Lake View Terrace, Shadow Hills and Sun Valley-La Tuna Canyon Community Plan review process at the earliest possible date and that STNC seek support of the Sun
