Victor opens Q&A regarding Home Depot. Asked Dale if he discussed with HD a trade of locations to Sun Valley instead. Dale says no 10 acre parcels available in Sun Valley at the time he approached the subject with the other Council office there.

Public Comments: Sister Elsie opposition – will be on next Monday's agenda. Steps to the Library from behind the North Valley City Hall. Several attending in opposition to Home Depot. Several attending in opposition to Hope Gardens.

Minutes of July 17 approved as corrected.

Agenda Item 5 b. – Kagel Canyon – Opposition to Hope Gardens. 27 similar facilities in the area already. Fire and safety is a concern with this project. Fire in this area would be catastrophic. Starts with 300 children including teenagers (that smoke). Oak trees already chopped down. Failed project in Pasadena. Three year transition of a mother with a seventeen year old means he will turn twenty while she's there.

RN – Too large and not successful and rate of recovery is very small. Most difficult to keep in recovery are women and children. The women can and do leave at will with their children. Six year olds are the most

Drug problem is very severe up here. Needle exchange program is up here not because there were no needles. Most of these women and children have mental health issues. They should be given apartments and jobs (map provided does not indicate one in Sunland-Tujunga).

Abby Diamond – Is Home Depot pursuing (still) demolition (track 2) plan as well? Dale explains the two track application submitted by HD. They are still pursuing both applications. Board questions taken. Deborah Ray what other actions has Wendy Greuel's office taken to support the community and stop this development. Dale outlines what has been done and what actions have been taken. Dr. DeMulle said three reporters assigned to ask HD questions and they did not respond. HD representative from Latham and Watkins responds that she does not know why. Penny Blackwell would like to see new mayor send a letter to HD. Mr. Barrett has asked several times. Mayor declined. Don't count on the Mayor. Others voiced disapproval. Appeal process is ongoing and this is not over. Scott Svonkin (representing Home Depot through Dakota Communications) is new PR firm for HD.
